CONSTITUTION OF THE JUGGLE UP CLUB OF MT. CLEMENS

CONSTITUTION

ARTICLE I. Name

The name of this organization shall be "THE JUGGLE UP CLUB OF MT. CLEMENS".

ARTICLE II. Interpretation

Section 1. In this constitution and in the Bylaws and any resolution unless context otherwise requires:

"Club" shall mean Juggle Up Club of Mt. Clemens.

"Officers" "President" "Board of Directors" etc., shall mean the officers, President, Board of Directors, etc., of the club as provided for in this constitution and the Bylaws.

"Bylaws" shall mean the Bylaws of the Club as they may be adopted or amended from time to time in the prescribed manner.

ARTICLE III. Membership

- Section 1. Membership in the Club shall be restricted to no more than 125 General Members and elected to membership in the manner prescribed by the Bylaws.
- Section 2. Members in the Club who live Outside a 200 mile radius of the Annual Reunion Site may be awarded Out Of State Membership if approved by the Board of Directors.
- Section 3. Members in the Club who have been active members for 30 consecutive years will receive Golden 30 Member status and will not be counted in the 125 Regular Membership. There is no limit to the number of Golden 30 Members.
- Section 4. Members in the Club who have been active members for 50 consecutive years will receive Honorary Member status. Dues will be waived for all Golden 50 Members.

ARTICLE IV. Officers

- Section 1. The Officers of the Club shall be a president, four vice-presidents, a secretary, and a treasurer.
- Section 2. There shall be a Board of Directors which shall consist of the Club Officers and the immediate Past President.
- Section 3. The officers shall be elected in the manner prescribed in the Bylaws.
- Section 4. All officers shall hold office for one year or until their successors are elected or appointed.
- Section 5. In the event of any office becoming vacant for any reason, the vacancy shall be filled with the least possible delay by the Board of Directors.
- Section 6. The officers and Board of Directors shall perform such duties as are prescribed by the Bylaws.

ARTICLE V. Revenue

Section 1. The Revenue of the Club shall be derived from the fees from time to time paid by the members thereof in accordance with the Bylaws, together with such sums as may from time to time be raised by various activities of the Club.

ARTICLE VI. Meetings

- Section 1. Meetings of the Club shall be held as such a time and place as may be determined by the Board of Directors.
- Section 2. The annual meeting of the Club shall be held in September of the second Saturday following Labor Day.
- Section 3. A Past Presidents meeting will be held at least 5 days prior to the Annual Meeting where club business will be conducted.
- Section 4. Special meetings may be called and held in this manner for the purpose specified in the Bylaws.

ARTICLE VII. Amendment

Section 1. This Constitution may be amended by a two-thirds vote of the members present at any regular meeting of the club, provided that notice of any proposed amendment shall have been given in writing at a regular meeting at least two weeks prior to the date at which amendment is to be voted on, and that such notice shall have been communicated by the Secretary to each member of the Club in good standing as least one week before such voting.
